Did You Know: over 60% of FIAMC's Care-Receivers live below the Poverty Line? The economy is forcing more seniors to decide between medical care, purchasing prescriptions, or buying food. Faith in Action of Marathon County **fills the gap** for Care-Receivers who could not get by without our **NO-COST** services.

FIAMC is an "Essential Business." More area seniors need our unparalleled, indispensable services! These uncharted times demand measures requiring navigation through this economic downturn. To provide the best possible service to our vulnerable senior residents, the FIAMC team has been working on a large project. Our new Customer Resource Management application (CRM) is replacing our outdated "RideScheduler." The CRM will further allow us to ascertain any referrals for services we cannot provide. To defray any out-of-pocket expenses Care-Receivers would incur from referred services (i.e., light housekeeping, Medi-van, essential/basic home repairs, home safety equipment, etc.), FIAMC is seeking funds to provide vouchers for those services.

Even in this time of uncertainty, our services supply the essential means that help seniors during this "new normal." As the situation continues to evolve, we will persevere in leading through the lens of our Mission Statement: "Faith in Action of Marathon County is a Non-Profit Organization connecting compassionate volunteers with senior neighbors (60+.)
